**Postponement & Rescheduling of 11th COSIDICI National Award Function 2025 &
Executive Committee Meeting at Vishakhapatnam {A.P.} – Intimation Reg.**

This has reference to COSIDICI' letter of even number dated June 24, 2025, wherein it was informed that the 11th COSIDICI National Award Function 2025 is scheduled to be held on November 21, 2025 followed by the Executive Committee Meeting on November 22, 2025, at Visakhapatnam, Andhra Pradesh.

2. Andhra Pradesh State Financial Corporation (APSFC) has informed vide their letter No.AFC/HO/2025-26 dated August 14, 2025 that the Partnership Summit 2025 being hosted by the Industries & Commerce Department, Government of Andhra Pradesh, is scheduled to be held in Visakhapatnam on November 14th – 15th, 2025.
